CIRCULAR

It is hereby notified for information of the Members of the Bar and the parties appearing-in-person that in order to further streamline the procedure of filing/re-filing, the Competent Authority has been pleased to direct that :-

1. Whenever a case filed at the Filing Counter is found to be defective, the defects shall be communicated to the petitioner, but copy of the petition and court fee stamp tendered, shall not be retained by the Registry of this Hon'ble Court.
2. If the defects are not removed within 90 days from the date of communication of the defects, the matter shall not be listed before the Hon'ble Judge in Chambers.
3. As soon as the case file is returned, after indicating the defects, it shall be reflected on ICMIS Software in the category of "**Cases under Defect List Valid for 90 Days**" instead of under "**Case Status**" and if the matter is not re-filed within 90 days from the date of communication of defects, such cases shall be reflected in the category of '**Defective Matters Not Re-filed after 90 Days**'.

The above procedure shall come into force with immediate effect.
